# EQUINE COLIC AWARENESS MONTH OFFICIAL "SPOKES HORSE" CAMPAIGN TERMS AND CONDITIONS

> The "Equine Colic Awareness Month Official 'Spokes Horse' Campaign" (the "Promotion"), is a sweepstakes. One Winner will be selected from all eligible entries. NO PURCHASE NECESSARY. To enter, you must: (a) be a U.S. citizen residing in the Continental United States; (b) be 18 years of age or older at the time of entering the Promotion and (c) not be considered a minor in your state of residence. Adult parents or legal guardians may enter on behalf of their minor children, so long as all other requirements for the Promotion are met. In such case that a minor child's entry is selected as the Winner of the Promotion, the minor participant will be presented, along with the winning horse, as the official "Spokes Horse" of Colic Awareness Month, according to all terms detailed below. However, the adult parent or legal guardian will be the legal "winner" of the Promotion and recipient of the prize and, as such, will accept all legal responsibilities for the prize, including federal or state taxes.
